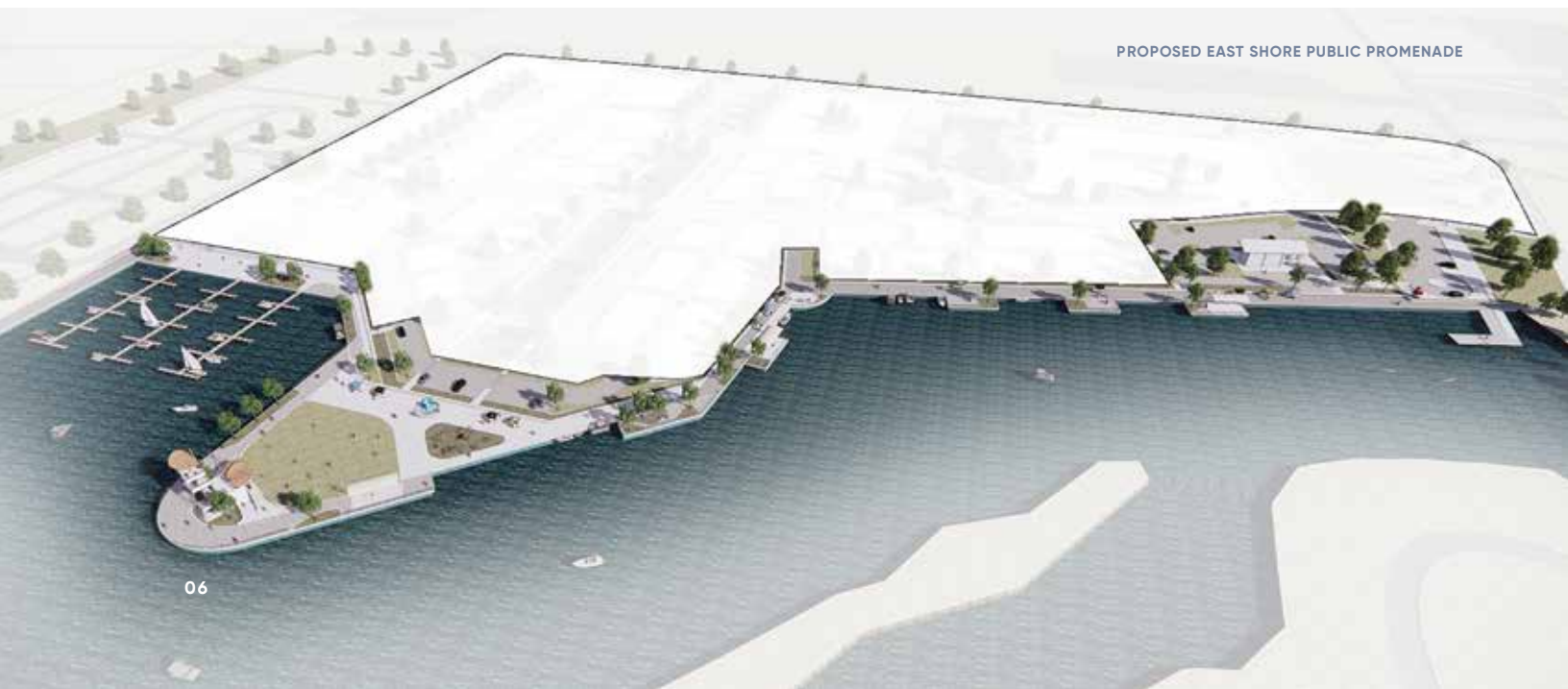


# HIGHLIGHTED ACCOMPLISHMENTS

Since its founding, the Buckeye Lake Region Community Foundation has achieved many significant milestones. Below is a highlight of major BLRCF accomplishments achieved over the past four years:

## BUCKEYE LAKE REGION COMMUNITY FOUNDATION: MAJOR ACCOMPLISHMENTS AT-A-GLANCE 2016 TO 2022

- Established the Buckeye Lake Region Corporation, providing continuous monetary and organizational support
- Serve as the primary funding resource to execute the vision of the BLR 2036 Declaration
- Funded the Gruen + Gruen Economic Impact Study
- Funded the EMH&T Buckeye Lake Watershed and Feeder Channel Water Quality Study
- Established charitable giving funds at the Licking, Fairfield and Perry County Foundations
- Coordinated and funded the Buckeye Lake Region Hospitality Plan executed by MKSK
- Coordinated and funded the Public Access Crystal Lagoon Economic Study executed by VenuBlue
- Coordinated and funded the Thorn Township Advisory Task Force
- Coordinated \$1,200,000 in grants for Feeder Channel restoration
- Secured \$200,000 for dredge recommissioning.
- Successfully advocated for the purchase of a new dredge for Buckeye Lake
- Secured \$392,000 for the Phase 1: Design and Concept to support the Buckeye Lake Region Corporation’s efforts to re-imagine the North Shore Park
- Secured \$75,000 to support the Buckeye Lake Region Corporation’s efforts to bring a public access crystal lagoon to Buckeye Lake
- Secured \$250,000 to begin structural and amenity upgrades to Canal Drive in Millersport
- Established the Thorn Township Taskforce along side Buckeye Lake Region Corporation to fund design support for possible development options along Honey Creek
- Worked collaboratively with Buckeye Lake Region Corporation to facilitate community focus groups and surveys to identify the top priority projects to be funded; water quality topped the list across all of the options
- Provided support to Buckeye Lake for Tomorrow installation of aerators across the Region to improve water quality
- Took over financial and organizational support for BLASST

# 2022 GOALS AND PROJECTS

The Buckeye Lake Region Community Foundation seeks to achieve its mission by funding approaches that contribute to the transformation of the Buckeye Lake Region. Below is an overview of projects the Foundation was focused on in 2022 along with funding goals and project status.

## MILLERSPORT CANAL RESTORATION

Capital Grant requests resulting in \$425,000 to initiate restoration improvements to the Millersport Canal. Work to begin in 2023.

## FEMA GRANT APPLICATION

Initiation of the FEMA grant application to alleviate flooding on I-70 and the South Fork Licking River. The project has been handed off to Licking County. Application to be submitted in early '23, grant awards to be announced summer 2023.

## BLASST COMMUNITY EVENT

Assumed all production and fundraising duties for the Buckeye Lake Area Star Spangled Tradition Independence Day Celebration.

## BUCKEYE LAKE WATER QUALITY

Partnerships with other community organizations to positively impact water quality. Impact to date: Approx. \$80,000, with \$40,000 coming directly from the BLRC in a "1-1" match against donations raised.

## THORN TWP DEVELOPMENT ASSISTANCE

Provided visionary design work to Thorn Twp for properties proposed for development. While the township paid the BLRC \$1,000, it cost the BLRC over \$10,000 to conduct community outreach and provide this service.

## NORTH SHORE PARK & PIER

Successfully applied for \$550,000 in Capital funds for community outreach, design and engineering.

## CRYSTAL LAKE

Grant applications totaling approximately \$125,000. Currently working on activating the grants to begin siting and design options.

## BLRC NORTH BANK MEETING FACILITY

Retained a professional, private facility available for community organizations across the region to conduct meetings and other community events.

## FORMATION OF THE COMMUNITY IMPROVEMENT CORPORATION

This entity will have the authority to possess properties and manage development. The first property to be managed by this CIC will be a public shoreline park that stretches over 2400' along the easternmost edge of the lake. This park will transform public lake access in an area where nearly none exists.



# 2022 FINANCIALS AT-A-GLANCE

In 2022, the Buckeye Lake Region Community Foundation received generous donations from a range of individual contributors and Champion of the Lake donors.

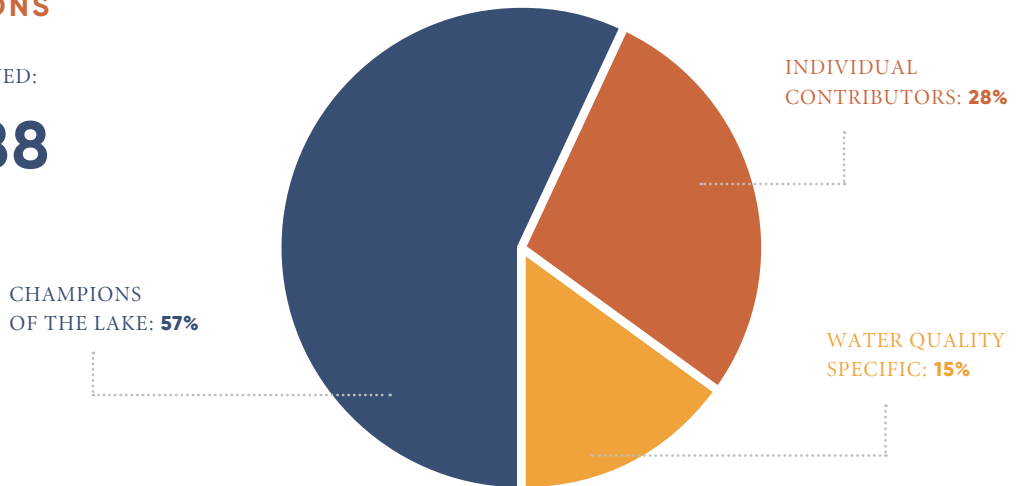
In 2022, the Foundation also received financial support from individual donors that participated in the Columbus Foundation Big Give 2021 event; these individual donations were matched by the Columbus Foundation. In addition, both the Fairfield County Foundation and the Licking County Foundation provided matching funds to donations made by donors during annual Giving Tuesday events, such as the Fairfield County Foundation 30-Hour Give event. This year, a significant portion of donations were earmarked – by donors – to support water quality initiatives.

These financial contributions were utilized to continue forward momentum on critical, regional projects as well as to maintain the operations of the Foundation and the Buckeye Lake Region Corporation.

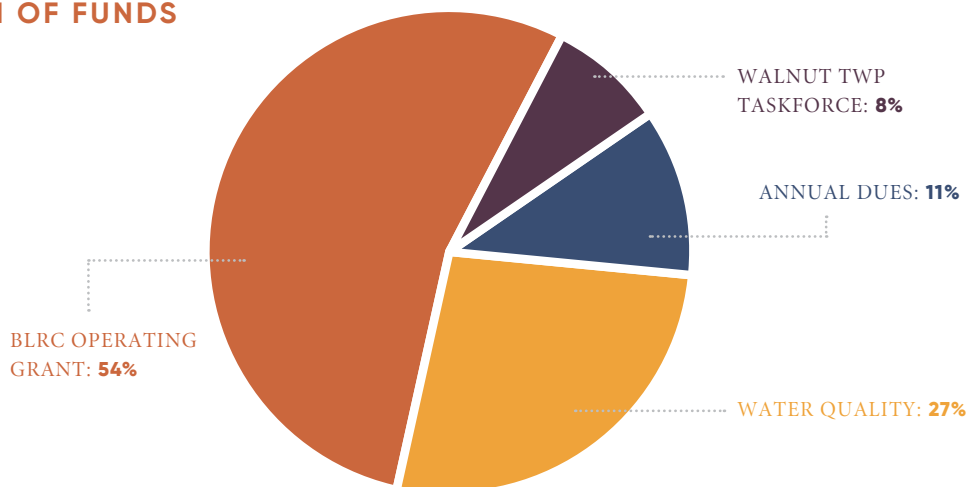


## 2022 DISTRIBUTION OF FUNDS


